

ESD VINYL SHEET FLOORING

COLLECTION MANUFACTURING DEFECTS WARRANTY LIMITED COMMERCIAL WARRANTY

This warrants that all ESTY Floor ESD vinyl tile flooring products as shown above will be free from defects in materials and workmanship for a specified period from date of invoice, provided that the warranty set forth shall apply only if such products are installed and maintained in accordance with the written instructions published by ESTY ESD vinyl tile Flooring Such warranty shall be voided if such products are removed from the site of their original installation .

TERMS WITHIN ONE YEAR: If a defect covered by this warranty is reported to ESTY ESD vinyl tile Flooring within one year of purchase, We will supply new material of same color, pattern and quality to replace the defective material;

WITHIN TWO YEARS: If a defect covered by this warranty is reported to ESTY ESD vinyl tile Flooring . ESTY will provide material of same color, pattern and quality to replace the defective material.

Warranty Action:

ESTY ESD vinyl tile Flooring may require inspection of any claims, and request photographs and/or samples prior to approving claims. All ESTY Flooring is warranted against manufacturing defects, improper wear, fade or stain acceptance that would result in loss of original pattern and color, under normal use and maintenance, from the date of purchase through the specified times stated in this warranty. Products must be installed and maintained according to the ESTY Flooring Installation & Maintenance Instructions in order to be covered by this Limited Warranty.

Upon receipt by ESTY Flooring of above information, arrangements will be made for an ESTY Flooring representative to inspect the material believed to be defective.

Warranty Exclusion	
⇒ Damage caused by improper storage and handling prior to installation	⇒ Situations created by and resulting from excessive moisture, alkali or hydrostatic pressure, mold and mildew in substrate.
⇒ Material utilized for other than prescribed use as flooring, or otherwise deemed appropriate by ESTY Flooring.	⇒ Situations created by and resulting from flooding, standing water and temperature extremes.
⇒ Material installed with obvious defects	⇒ Telegraphing of adhesive trowel lines, joint lines, underlayment fasteners, etc. Situations created by or resulting from lack of or improper protective matting at entryways, landings and pivot points.
⇒ Conditions resulting from installing, utilizing and maintaining flooring not in conformance with ESTY Installation Instructions for Installing Interior Flooring Products – most current edition at time of installing.	⇒ Damage Resulting from abuse including, scratches, burns, cuts, etc....
⇒ Material not installed with ESTY adhesive proper for the flooring specified or for the jobsite conditions and intended use.	⇒ Damages to the Sub Floor
⇒ Material not maintained according to ESTY recommended maintenance procedures.	
⇒ Heavy Wheeled Traffic
